The focus of his recent work has involved efforts to improve land access and affordability, and provide technical services to new and beginning farmers. He serves on the UConn Extension Solid Ground Farmer Training cadre, where Kip provides training, one-on-one consultations, and site assessments on land access, soil health, and climate change.

He is a recognized regional and national speaker on soils and land use planning, farmland protection, climate change adaptation, and farmland access. Kip is the Co-Chair of the Working Lands Alliance and a member of the Connecticut Council on Environmental Quality. In addition to this wealth of professional experience, Kolesinskas is an avid fisherman, cook, gardener and local foods advocate.



One of the things we have heard the most from our more advanced "Beginning Farmers" is that they struggle with finding and keeping good workers on their farm. If you are interested in becoming a mentor or mentee, CT NOFA will connect you with another farm and support you through the process for a year. Farmers on both ends are matched with folks that best fit their operations so that the work is relevant to your business goals.

#### **WEATHER-RELATED LOSSES 2023 & 2024**

In December, a resolution was signed into law which secured \$220 million for U.S. Department of Agriculture (USDA) to provide block grants to eligible states, including Connecticut. This funding is intended to compensate producers for expenses and losses incurred due to weather events in 2023 and 2024.

CT Dept of Ag is collecting information from farmers regarding weather-related losses incurred in 2023 and 2024. This data will help us collaborate with the USDA to implement a financial relief program for these losses. Your response will assist in determining the amount of funding Connecticut should request from the federal government, as well as the types of losses that should be covered.

The survey includes questions about losses from specific weather events in 2023 and 2024, as well as losses related to long-term stresses worsened by weather conditions during these 2 years. The survey allows you to report up to 3 separate losses. If you have more than 3 losses to report, please submit multiple forms.

It is essential that we gather comprehensive data to fully represent the scope of losses. We encourage you to participate in this survey even if you have already received grants, loans, or insurance payments for the indicated losses. When the program application is launched, these payments will be considered.

**Please note:** responding to this survey does not guarantee access to or eligibility for funding. The parameters of state and federal programs are still being finalized. Not all types of losses reported in this survey may qualify for compensation. All responses are subject to the CT Freedom of Information Act. While participation is anonymous, you may provide your email addresses to receive timely notifications about the program launch. The survey will remain open until 11:59 p.m. on Sunday, January 19, 2025.

# Online Climate Smart Adaptation Strategies for Beginning Farmers Course

UConn Extension is coordinating two offerings of their Climate **Smart Adaptation Strategies** Course, beginning on February 3rd, and March 5th. This is an online course designed for new and beginning farmers in CT who have 1-10 years of farming experience. Participants will learn about the impact of climate change on CT Ag and discover a range of adaptation strategies. The price is \$60, with a \$30 refund after completion. Completion of this course is required to be eligible to apply for the Spring 2025 round of **UConn Extension's Climate Smart Adaptations Microgrant Program** (which is limited to farmers in CT with less than 10 years of experience operating their own farm business).
