MAY FARM TASKS: MANAGING INVASIVE PLANTS

Every year, when we head out to our fields to prepare for spring planting, the same thing happens- we see new areas that invasive plants have found their way into. It's a frustrating when mugwort shows it's face in a place you've never seen, or the Japanese knotweed has found it's way onto your property. Not to mention the bindweed, bittersweet, multi-floral rose, etc etc.

However, there are tools available to help you! The CT Invasive Plant Working Group out of UConn came up with a <u>"Invasive Plant Management Calendar,"</u> developed by Emmett Varricchio and CIPWG collaborators. This seasonal guide helps you understand steps you can take to combat the top 10 invasive plants including the best times and methods to manage these species effectively.

The calendar outlines Best Management Practices (BMPs) for each species based on growth cycles and seasonal timing. Management strategies are divided into mechanical (cutting, pulling, mowing) and chemical (foliar sprays, cut-and-paint, stem injection, and pre-emergent herbicides). Each method is matched with optimal application windows and specific plant vulnerabilities, such as flowering or seed dispersal periods. And because we don't want these invasives taking root anywhere else, disposal recommendations are included, stressing the importance of preventing re-rooting or unintentional seed dispersal.

Though this guide can help you act in the windows that are most effective for combating invasives, it still encourages you to take steps at any time of the year. Whenever you act however, please consider pollinator activity when applying herbicides (even organic ones)!

We know some invasives you all are facing haven't made this list, but there is still help for you. If there is a specific invasive that you are struggling with, feel free to sign up for a free consultation with our IPM specialist, Shuresh Ghimire. He can help you make a plan to manage whatever is finding it's way into your fields. Happy Farming!



Want to know more about TOPP and how it's been helping farmers? Lucky you, they recently came out with a report on their 2024 impact. The Transition to Organic Partnership Program (TOPP) focuses on mentorship, technical assistance, community building and market development to help U.S. farmers meet growing domestic demand for certified organic food.

So far in 2024, TOPP's impact is substantial, having helped certify 3,863 new operations and more than 260,000 new organic acres across the nation as part of a growing organic ecosystem. The program has connected 327 transitioning producers with 237 experienced organic mentors and delivered technical assistance through nearly 1,500 events reaching thousands of producers and agricultural professionals in every state and several U.S. territories. Though these statistics are nationwide, the farms here in CT are part of that, and you could be too! Check out the report and learn more about their program below
