2026 FSMA PRODUCE SAFETY RULE GROWER TRAINING

Are you interested in improving your produce safety? The Produce Safety Rule states that at least one responsible person must complete training if you sell over \$500,000 (three year average) worth of fresh produce OR that sells more than \$25,000 and up to \$500,00 (three year average), if they do not meet the requirements of the Qualified Exemption.

The Produce Safety Alliance (PSA) Grower Training Course has been designed to provide a foundation of good agricultural practices knowledge that includes emphasis on co-management of food safety and environmental management goals, while outlining the requirements of the Food Safety Modernization Act (FSMA) Produce Safety Rule. The PSA Grower Training Course is one way to satisfy the FSMA Produce Safety Rule.

If you're like us, you're itching to start seeds and checking trays every two hours to see if anything has popped (we shared more seed-starting tips in last year's newsletter). But while the snow is still melting and you've (hopefully) got a little desk time left, this is the perfect season to create an SOP.

SOP stands for Standard Operating Procedure. In plain terms, it's a clear, step-by-step guide for how a specific task gets done on your farm.

Why bother? Because if more than one person is involved in the work, things can easily get lost in translation. Everyone has their own way of doing a task. And often, not everyone knows the why behind certain steps. An SOP gets everyone on the same page.

When created thoughtfully—whether on your own or with your team—an SOP can:

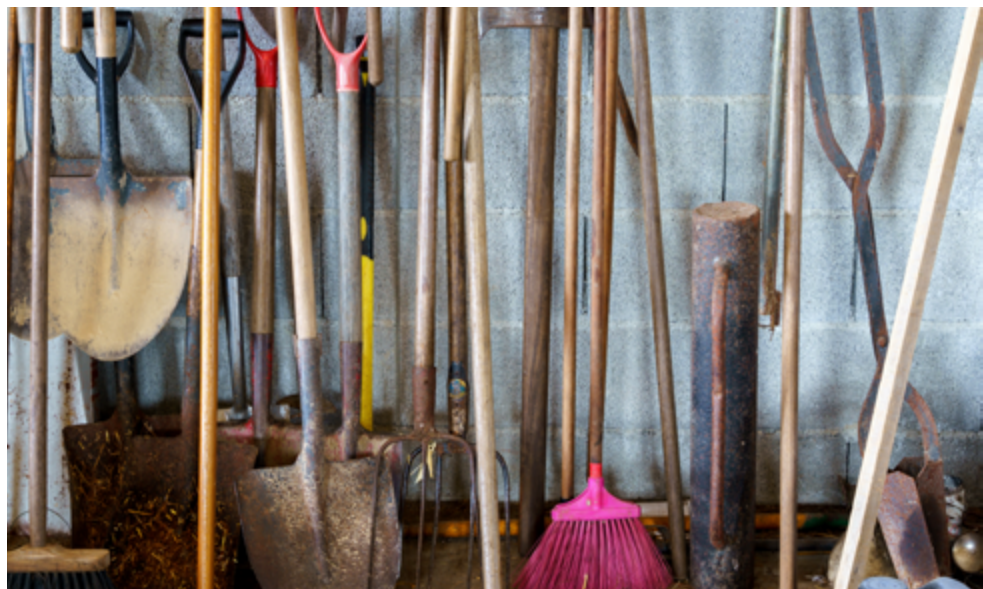
- Create consistency
- Reduce mistakes
- Save time spent re-explaining tasks
- Preserve knowledge from previous activities
- Support produce safety and sanitation
- Make training new crew much easier

This “pre-work” can feel like another task, but you don't have to tackle everything at once. Start with just one task and write down exactly how it's done and why. Test it. Refine it. Notice what changes.

If you'd like guidance, the [University of Maine Extension has a helpful article](#) that walks through both the “why” and the “how” of creating an SOP, along with a worksheet to get you started. They also include examples of farm tasks that benefit most from having a written procedure.

So give it a try, and hopefully it will make things a little easier this year. Happy Farming!
